The Delta DX Association (DDXA) has asked me to urge all clubs and members in our section to contact their U.S. Senators and Representatives regarding the harmful interference possibilities of Broadband over Power Line (BPL). The DDXA believes an informed Congress will help provide a more rational process and I agree. With the recent comments by the Federal Emergency Management Agency (FEMA) regarding BPL, we now have a strong ally on this issue. However, we must not assume at this point that the battle is over. In contacting your elected officials you should point out that FEMA's comments to the FCC echo those of the ARRL and other groups representing users of the HF spectrum. Moreover, our officials must understand, as FEMA makes clear in its comments, that there is no alternative to HF in terms of meeting national security and emergency preparedness requirements at the national, state, and local levels. Although the League's Logbook of the World (LoTW) has been operational since mid September, it was late November before I joined the nearly 5,000 hams worldwide already participating. LoTW allows us to submit QSO data electronically that can be used for awards credit. If you haven't done so already, be sure to check out the details of this excellent program on the ARRL website and in the October issue of QST. BPL comes to Washington I normally let SEC Jim Pace, K7CEX have this space but I think BPL (Broadband over Power Lines) is an important topic we all need to be aware of. On 4 Dec. I made a presentation to the WA State Senate Technology & Communications Committee on the interference issues associated with BPL. The purpose of the hearing was to educate the

committee on the BPL technology. The agenda was; Part I What is broadband over power lines and how does it work? Where is the technology being used? Presenters were: Christopher Britton, President and & CEO, IDACOMM. IDACOMM is the telecommunications subsidiary of IDACORP, the holding company of Idaho Power. Bill Simons, Director of Business Development, Amperion, Inc. Amperion is headquartered in Massachusetts. It develops networking hardware and software that enables the delivery of high-speed broadband data over medium-voltage power lines. Ed Bruette, American Radio Relay League, the national association for amateur radio. Part II (BPL examples in Washington): John Smith, Director of Networks, Chelan County PUD No. 1 Dale Knutson, Telecommunications Manager, Mason County PUD No. 3 As you can see I was after the industry. My presentation was done with the aid of PowerPoint and outlined the Part 15 device limitations, the interference issues both to and from Amateur Radio, BPL trials in Europe and Japan and the other users of the spectrum who will be impacted by interference by BPL. I concluded with a quote from the NTIA comment to the FCC NOI that indicates BPL is a promising technology but before deploying BPL the existing licensed users of the affected spectrum must be protected. The first 37 seconds of Ed Hare's BPL video (http://www.arrl.org/tis/info/HTML/plc/#Video) were included in the presentation along with a NTIA spectrum allocation chart that I modified to show the potential loss of spectrum. The committee did not ask any questions after my presentation. The nonverbal feedback I got from the committee was positive, as was the feedback from the 4 Hams in the audience. I was pleasantly surprised to hear the industry say the power line is an antenna. Equally surprising was an admission by the Chelan Co. PUD that they have gotten letters from local Hams after the deployment of BPL. Mason Co. PUD made a presentation because they are looking to deploy BPL in Dist. 3. We need to be vigilant and report all instances of interference from BPL. Those reports need to be made to the operator of the system and the FCC. Remember, BPL is susceptible to interference from Amateur Radio. If that happens in your neighborhood you may find yourself face to face with an angry BPL user who does not understand Part 15 device regulations. They just know you are a Ham and are a potential source of interference. If that happens, diplomacy is the best response. Support for my presentation was provided by DEC Ken, K7TAG and SGL Lee, KI7SS. Attending the hearing were Lee, KI7SS; Dan, KB7DFL; Bob, N7JHJ and Bill, WA7NWP. Thank you all. Thank you also to Ed Hare, W1RFI the ARRL Lab Manager who shared his knowledge and a previous presentation.
