SECTION NEWS SOUTHERN NEW JERSEY JANUARY 2004 JEAN PRIESTLEY -KA2YKN HAPPY NEW YEAR TO EVERYONE. This year promises to be an interesting year one... We have a new hamfest in town, the BPL issue to deal with and the question "What will happen with Morse Code "? The new hamfest this year is sponsored by the East Coast Long Wire Assoc. and ARRL approved. It will be held in North Wildwood, NJ on June 20, 2004. Contact point at this time is Tony Cipollono, N2RKX On Friday evening Jan. 9, K2GW, Gary and AB2IO, Mike set up a panel and literature displays for the Super Science Weekend Amateur Radio Exhibit at the State Museum in Trenton, NJ complete with a straight key, code oscillator, message forms for traffic messages, HF and VHF equipment in preparation for the Exhibit on Jan 10 and 11. The station included handi-talkies, Yaesu FT-897 and FT-817 transceivers, and internal VHF/UHF LOG PERIODIC BEAM and a Buddipole HF dipole antenna erected outside. Many hams were signed up to take a shift. The weekend saw 10,000 children and parents. Visitors were shown the "Amateur Radio Today" video and given literature about Amateur radio and information on upcoming classes. Contacts using W2ZQ were made across the country and overseas on PSK-31 and via phone. Working with DVRA were hams from the Warminster Amateur Radio Club and the David Sarnoff radio club. Everyone enjoyed themselves and agreed it could be an annual event. The most important cause we can fight for in 2004 is the BPL issue. If BPL is allowed, we lose everything we have worked so hard to accomplish and maintain over the years. There is something we can do. We can learn and understand what BPL is all about. We cannot fight an enemy we do not know. We need to read and research the subject and then we can write those who can influence the FCC to not allow BPL use. Austrian Amateurs have opposed deployment of all BPL experiments as neither legal nor compatible with "vital, worldwide short-wave radio communication". Other countries are also against BPL. Two organizations have filed comments with the FCC that augment previously expressed worries about potential interference from BPL. FEMA expressed "grave concerns" and DERA called on the FCC to require impartial BPL field testing as well as additional public comment and full and open public hearings. If you are planning a trip to the Battleship New Jersey, plan a weekend trip. Except for school trips the Battleship will be closed to the public on Tuesdays, Wednesdays and Thursdays until sometime in April. This just makes good business sense because last year there were days that less than 15 people came to visit the Battleship in the middle of the week. The Homeport regrets any inconvenience. For special arrangements during those days, the same rules still apply in that you can come as a group but need to make arrangements for a control operator to be in the shack. If you are pondering membership in the Battleship's Amateur Radio Club, the best way is to come to the ship some Saturday and ask at the pier to have someone from the radio club on board escort you onto the

There were 42,010 check-ins to our traffic nets, and 23,597 pieces of traffic were handled. We spent 68,082 minutes during 2,548 sessions, and it was time well spent. Compared to last year, the check-ins have increased by 2,661 and traffic was up a whopping 1,788 pieces! That makes this the best year in the last five. The BWN accounted for 72% of the total check-ins and 83% of the traffic, but every net served a real purpose. It's true that 75% of our check-ins were to SSB nets, but that 25% on CW served as an important part of the system as well. Not only did we practice the handling of messages, thus sharpening our skills for use in an emergency, but we tested our procedures, picked up traffic-handling tips by listening, and became familiar with the patterns of other operators with whom we would be working if necessitated by a disaster. For those of you unfamiliar with this term, it is a 1985 FCC ruling that states local governments are required to reasonably accommodate Amateur Radio installations. Even though it is a Federal ruling, individual states such as ours, need to pass a statewide version of the law so that local towns have a point of reference. Over the next few weeks, I will be contacting you via e-mail as to how you can help us get this very important document passed into law. Rep Ira Trombley of Grand Isle was nice enough to introduce it, but it is now up to us to help push it through! As of today, it has no co-sponsors.

The proposed legislation can be viewed at http://www.leg.state.vt.us/database/status/status.cfm. Type H.602 in the box and hit enter. It is a nice piece of work, and I want to thank Trevor Lewis KD1YT for drafting it. Trevor is Vermont's ARRL Volunteer Counsel. I am announcing a 2 Meter Vermont Simplex Frequency that I want everyone to be aware of. It is 146.490 MHz. The Central Vermont Amateur Radio Club has been using this frequency to meet on after their Sunday evening net on the local repeater. They have had great luck with it. The importance of having a standard simplex frequency is to have a place to go to in the event that your local repeater is off the air during an emergency. I would like you to program it into all your 2 Meter radios and maybe even QSY to it once in a while if you are in a QSO with someone that is within range of you. If you have a priority watch feature in your rig, this would be a good frequency to program in there too. In other news, I am looking to fill the position of Public Information Officer in my Field Organization. A PIO kind of acts as a liaison between Hams and the news media. A number of proposals for the future of Amateur Radio had been mentioned as possible items for discussion, including the matter of CW retention as a testing element, but no

information is available yet about what was on their agenda. The League usually sends out bulletins containing items of special interest after these meetings, so watch your e-mail. As most of you know, Amateur Radio in New Mexico lost its biggest supporter when Joe Knight, W5PDY, passed away December 28, 2003. Joe had served for almost 27 years as New Mexico Section Manager, the longest serving SM in ARRL history. It's not going to be the same around here without him. ARCA is presently talking with the city officials about discount cost for motel rooms, RV parting spots, and Grand Canyon Railroad tickets. The RV part is located next door to the ground and has full hook-ups and there are several motels close by (Fairfield, Holiday Inn, etc). The next order of business is the 2004 ARRL Southwestern Convention that will take place at the Sheraton Wild Horse Pass Resort located near Chandler on 27-29 august 2004. The Central

Arizona DX Club is putting on this event and they do everything first class.
