were shown how APRS works. They were given a demonstration of how Morse code is used in radio communication, and a "name exchange" using code practice oscillators demonstrated that information using CW really works. Congratulations to the members of the MCARC for their efforts in demonstrating Amateur Radio to the Boy Scouts of their area. If your amateur radio group is doing Public Service, please let me, David Pifer N9YNF, and our Bulletin Manager Brian Murrey KB9BVN, know about what is happening in your area. Our SEC, Dave Pifer N9YNF, reports that many local groups are getting started with meetings with local officials and agencies. With the recent flurry of activity in the Homeland Security arena, we can anticipate more meetings and changes in how things are done. There are many new plans within the Homeland Security effort that are redefining how our clients do their business. All EC's and DEC's should be aware of the new Indiana Legislation, IC 10-14-3 which redefines portions of the EMA offices of each county. In particular it now includes statewide Mutual Aid Network (IC 10-14-3-10.6 and 10.7). In addition to this change there is now a public record law IC 5-14-3-4(b)(19) that contains specific wording that gives the right to withhold information from the public if it is deemed as a risk that could be used in a terrorist attach. Item (H) "The emergency contact information of emergency responders and volunteers" come to mind as information that we should guard. From time to time, the subject of a police radio in your car, or on your person, comes up. Every amateur should be aware of IC 35-44-3-12, "Unlawful use of a police radio," and its exemptions. I encourage you to look at the wording closely and see if you can spot the FCC and state law inconsistency. Also, remember that even though you are exempt with a "police radio" receiver in your car, what about your spouse, the auto mechanic, or anyone else who might happen to be driving your car, and isn't a licensed amateur? All EC's and DEC's should be aware that there is a new Public Service Activity Report Form (FSD-212) available on the ARRL's website: http://www.arrl.org/FandES/field/forms/ The most significant change is the person-hours vs. man-hours. Please take a look at the forms on the website compared to what you send, and get them up to date. Are you planning to attend a SKYWARN spotter seminar in your area during February or March. I hope so! LOUISIANA SECTION NEWS – JANUARY 2004 Burt AF5AA is the new Emergency Coordinator for Cameron Parish. ARES groups and ham clubs are encouraged to pursue Citizen Corps funding opportunities by contacting their local office of Homeland Security and Emergency Preparedness. As mentioned in last month's report, we want to strengthen the ties between the Amateur Radio Emergency Service (ARES) and the National Traffic System (NTS). Along these lines, our section conducted a joint ARES/NTS net on HF during the Sugar Bowl on January 4. Participating stations included W4DLZ (NCS), NF5B (NCS), WA5LQZ, K5OEP, W5KB, WA5RT, AC5TM, AC5VN, WB5ZED, N5CFL, and KN5GRK. I understand there were also a number of stations active on VHF nets in the New Orleans area during the Sugar Bowl. Fortunately, there were no incidents during the event. Thanks to all who donated their time and efforts for this public service event! Emergency Coordinators should now be aware of the new ARES award program announced in late January. Details of this program are spelled out on the section's website at www.laarrl.org Some of the scoring criteria recognize activities that each local ARES group should already be doing (submitting monthly reports, participating in local drills and public service events, participating in the annual SET, etc.). However, the last two categories (liaison of local nets with either LTN or LCW and handling formal messages on local nets) have been specifically included not only to encourage stronger ties between ARES and NTS, but also to provide training opportunities in formal message handling. ARES representatives should indicate their (weekly) liaison function when checking into LTN/LCW. Regarding message handling, one obvious source of formal messages for local nets is for each EC to send his monthly report via radiogram to the SEC. (However, WA5LQZ may want ECs to use a consistent format when sending their monthly reports by radiograms!) If anyone has any questions about this new award program, please let me know. The ARRL Board of Directors approved a proposal on license restructuring during the Board's January meeting. This proposal has now been submitted to the FCC for consideration. Although there's no way to know for sure, I believe the FCC will issue a Notice of Proposed Rule Making (NPRM) reasonably soon (for a government bureaucracy!) and we may very well have a new license structure in place by the end of this year. In any event, we will all have a chance to submit our thoughts, pro or con, on the ARRL's proposal once the FCC issues the NPRM. On another front, the FCC, unfortunately, has decided to go forward with a NPRM on Broadband over Power Line (BPL). The FCC is expected to issue its NPRM on BPL within the next few days. Rhode Island

Greetings Fellow RI Amateurs, On January 19th, ARRL released news of its license restructuring proposal to the FCC. This is a major event and it attracted comment from a wide spread of Amateurs. Its main feature is the elimination of a code requirement for any license except the Extra class. As anyone familiar with Amateur Radio could predict, reaction across all Amateurs was mixed. Since the World Radio Conference's agreement last summer stating that it will no longer be mandatory worldwide that an Amateur will be required to demonstrate proficiency of Morse Code in order to operate a transmitter on HF bands, i.e., below 30 MHz, more than a dozen countries, including the UK, Germany, Australia and others have eliminated code from their own testing syllabus. Further, there's every indication that more countries will join this group and further broaden and strengthen consensus support. No one I know likes change but the ARRL has taken a bold and daring move to prepare the greatest number of US Amateurs for the best and widest use of our spectrum in the next decade. I believe ARRL felt they had to submit this proposal in view of the broad initial actions of its IARU partners and with regard to its own leadership role in IARU. This new ARRL initiative will allow Technicians into the HF bands with very attractive operating limitations. Technicians when grouped with the existing Novice population make up 52% of all US licensees and this entry segment of our licensee base is growing rapidly. In 2003, more than three quarters of all new licenses issued were to Technicians. We must quickly seize the opportunity and encourage

growth in this new group of Amateurs if we hope to see a future for our hobby. They are our future! From the hour the news broke, I heard the usual anti-ARRL elements complaining. I heard complaining that they just don't like change or that we old timers did it the right way. My reply is "Get over it". Most of us don't use manual shifts in cars, nor do our kids walk three miles to school any more. The world has changed and we must change with it or be left behind. Helen Keller, famous advocate for the blind in the last century was quoted as saying that "None are so blind as those who will not see." The nay-sayers are being quite wrong in failing to see the timeliness of this effort and offer their support to the ARRL proposal. They will benefit from it and still they won't support the ARRL. They are truly the ones who fail to see. Some of us will still use and love CW long into the future. Whether required or not in a test, I absolutely know that many avid DXers and contesters will be as proficient in CW 25 years from now as they are today, even if they only passed a 5 wpm test to receive their license. CW is efficient and a very thrifty user of spectrum space, a fact that all informed Amateurs realize. When the FCC officially receives this petition and files a Notice of Proposed Rule Making (NPRM) for it, all your comments will be invited and welcomed. Until that time comes, it is premature to file comments, whether pro or con since the FCC will not be ready to post and evaluated them. The statewide CERT program is rolling along very nicely. Instructor W1VH has graduated his Bristol group and is presently nearing completion of the Tiverton class. I've heard that four or five graduates have already bought radios and are on the air. THAT'S TERRIFIC! Following Tiverton will be a CERT class in East Providence, Newport and eventually, the rest of RI. Conservatively, this program should produce a hundred or more new hams in RI. MANY thanks to our club VE teams for providing testing services to these CERT classes around RI. On a related item, our CERT group instructor, W1VH completed his Level II ARECC training at the head of his class, scoring 100% in the final evaluation. Congratulations, Bill! The FCC has issued a Notice of Proposed Rulemaking on the Broadband over Power Lines (BPL) issue. I'll have more information on this topic next month, as the NPRM has not appeared in the Federal Register yet, but this is an issue worth watching. Both Duke Power and Progress Energy have expressed an interest in BPL and will be conducting trials during the early part of the year. Both companies have expressed a willingness to work with hams to make sure our concerns are considered. If you are identified as being within a test area, you may be contacted and asked to report your observations and measurements - if so, try to be as accurate as possible in measuring and describing any interference you observe. Anecdotes, heresay and exaggeration will not make our case, accurate data and observations will. I am sad to report that Joe Henderson, WD4MRD became a silent key on February 14. Arizona

The complete article is lengthy because of the PIMA County antenna ordinance issue. Please see the ARRL Arizona Section We page at http://www.arrl.org/sections/AZ.html for the full article. First I need to report that Arlene Ellis, WD6ASB, passed away this last month on the 27th. Arlene was the wife of Charles Ellis, W6PNM, who is very active in the Amateur Radio Council of Arizona (ARCA) and is my District Emergency Coordinator for Mohave county. Arlene was very supportive of amateur radio in the Kingman area and throughout the state. They opened their home to me on various occasions when I needed a place to stay while visiting the clubs and Hamfest in Northwest Arizona. Many people within our amateur radio community will miss Arlene. As was reported last month, PIMA County is in the process of revising the amateur radio tower regulation. Bill Jorden K7KI, Ken Hirschberg, K6HPX, and myself, Clifford Hauser, KD6XH, have been part of the civilian committee and have been trying to fight this issue. If this ordinance passes, amateur radio emergency communications within PIMA County will be heavily curtailed. On February 25th, the county planning and zoning board will meet at 201 N. Stone Ave. to propose that the county supervisors approve the ordinance. There

are two (2)-unresolved issues in this proposed ordinance. The amateur radio members say a minimum height of 75 feet with a minimum of two (2) towers per property is required for adequate communications. The homeowners association (Gates Pass residence) contends that a maximum of 34 feet and only one (1) tower per property is acceptable. As you can see, 34 feet is unacceptable even for VHF/UHF operation. One (1) tower per property will not even allow a person to install a dipole antenna. I have attached a copy of my cover to all amatuer radio operators and the proposed ordinance change. It is on the ARRL Arizona Section Web page. Please review these documents and write your supervisor on why this should not pass. My position as your ARRL representative is that no change is necessary. The present ordinance has no history of safety violations or any other valid complaints except for this one (1) group of people who are part of a small portion of PIMA County. Why should the county supervisors impose such restrictions on the rest of the county because of a complaint about "An unsightly tower" in a small portion of the county. Due to the seriousness of this issue we are going to engage the services of a lawyer who is an extra class license holder and who is will to help us a minimal expense. As you know, lawyers are expensive and a fund has been set up for you to help us with the expense. You can send your donations to myself or PACE engineering on Prince Road. All money collected will be used for this purpose only. This is a political fight that will effect our ability to communicate with PIMA County, the state of Arizona, the United States of America, and the world. Once in place, any ordinance is hard to remove. The Arizona State Hamfest, normally located at Fort Tuthill in Flagstaff, is now going to be at the Williams, Arizona Rodeo Grounds, and the date will be the first weekend in July the 2nd through the 4th. The RV part is located next door to the ground and has full hook-ups and there are several motels close by (Fairfield, Holiday Inn, etc). The 2004 ARRL Southwestern Convention that will take place at the Sheraton Wild Horse Pass Resort located near Chandler on 27-29 august 2004. The Central Arizona DX Club is putting on this event and they do everything first class. The convention web site is "www.hamradio2004.com/swdc2004". The next Hamfest will be at the at the Scottsdale Community College on the 13th of March. The Cochise Amateur Radio Association will hold its Hamfest on 01 May 2004 in Sierra Vista, and Kachina ARC will have its Hamfest on 5-6 June 2004 in Show Low. The State Hamfest in Williams on the 2-4 July 2004.
