#### Mississippi

The results of the Mississippi QSO Party are in. Over 100 Mississippi stations were on the air in 61 of the 82 counties. Mississippi stations collectively managed to work all 50 states and 25 countries. The five highest scores in Mississippi were turned in by K5SVC, WQ5L, K5MDX, AG5Z, and W5PFR. The high score outside of Mississippi was racked up by K4MUT in Maryland with 67 QSOs in 42 counties. Complete results and certificates will be mailed to all of those stations submitting logs. Should we have another one next year? Comments? In ARES news DEC W4WLF reports that Harrison County ARES participated in Lifesaver 2004 which was a major Homeland Security Drill involving simulated terrorist attacks over several states. ARES operators in Harrison County maintained communications among EOCs in Mobile, Gulfport, and Jackson. In Lafayette County EC K5DSG reports that ARES has the new call W5LAF and has a permanent meeting place now that the new county fire department central station is completed. In further ARES activity, Metro Jackson EC AC5SU reports that a weather drill was conducted on May 22 after the drill had to be cancelled on May 15 because of a real weather situation! The May 22 Drill emphasized mobilization of resources, net operations and coordination, and the transition from initial Skywarn/ARES response to recovery operations. He said that ARRL surveys indicate that about 22% of people who earn a new ham radio license never get on the air. I'm sure this is pretty accurate. This represents a challenge to us, but also an opportunity. All of us were new hams once, and most of us were introduced to ham radio by someone we know. Many more people now become hams by self-study, and they don't have that mentor to help them get started. There are several things we can do to encourage these new hams become an active part of the ham community. Make sure visitors to your club and ARES meetings are welcomed. I don't mean just ask for a show of hands for everyone attending who's a visitor, but make some special effort to talk to newcomers at the appropriate time before or after the meeting. If they are ignored, they won't come back. Some clubs offer "open house" activities which are strictly social, not a business meeting, and are a great opportunity for newcomers to get to know us a little better. Make sure they know about it! VE teams and licensing classes can give information about local activities. If possible, follow up with a phone call in a few weeks to make sure the new ham is on track to get on the air, and invite them to a local meeting. ARRL membership will help the person stay in touch with ham radio, as will membership in SERA, their local club and ARES group. By making new hams feel welcome, they will eventually become the leaders and doers in our organizations. I'm Section Manager today partly because members of the Cape Fear ARS made me feel welcome and helped me when I was a new ham. We should also look on this as an opportunity. Convincing the general public to become hams is hard - only about 1 out of 400 people nationally are willing to be hams. On the other hand, that 22% I mentioned represents a group of people who have already demonstrated an interest by going through the licensing process all we have to do is persuade them to become involved.
