Delaware Section Update. The 2004 hurricane season is well under way. There have already been 5 named storms this season. In the Delaware Section we have been very fortunate to date to have avoided much of their effects. One only has to look at the recent pictures from Florida to see the severe damage that these things can cause. Hurricane Charley also showed that while the forecasters have gotten good at what they do, slight shifts in tracking can result in last minute changes in the effects. We always need to be prepared to the possibilities when these things are headed our way. We also must be prepared to deal with the after effects. In the Delaware Section Amateur radio is a part of the Delaware Emergency Operations Plan. Our major areas of responsibilities are to provide back-up communications between the Various EOC and to provide communications to the Red Cross shelters when no other exists. We may be assigned others duties as well but these are the major functions we are assigned. I know that shelter operations is often perceived as something boring, and yes at times it may seems that way, but this is an important function. Often in these situations the amateur is more than just a communicator. They are someone who cares enough to be there when people are in need of someone to care about them. Clients in the shelters are often displaced, unsure of what going to happen and unsure of what they will find when they return. Having someone there that can provide even some information of what's happening, can make a big difference in easing the uncertainty. So when ask to help, please do. Some of you may have noticed that the FCC has tightened up on the rules for Declaring Communication Emergencies. Essentially they will not be doing such declaration for HF frequencies, except for 60 meters. So when operating HF during these times, please be aware of and courteous to any net or emergency operations. John Ferguson, K3PFW is requesting communications assistance for two Triathlons in Sussex County in September. One is Saturday the 19th, the other is Sunday the 26th. We are not limiting the appeal to just Kent and Sussex County but would like and could use anyone in the section willing to help out. If you are interested in helping please contact John, (or myself, and I will forward the info) for additional details. This is a good opportunity for us to work across counties. Northern New York

We had 23 Amateur Radio Operators involved this past weekend July 24-26 in communications throughout the course and three days. They come from our NNY counties, VT, Canada, NJ and other locations. They do a terrific job under very difficult conditions. We have Amateur Radio Operators in all the Ambulances except 3 which are stationary at the Medical Tent. We coordinate through Net Controllers and handle the Communications-Traffic from and to all the

locations along the course. On Saturday July 24th at 10am -4pm at the Horse Show Grounds our Volunteers are setting up (2) 30 foot towers, (2) 13 Element VHF Beam Antennas, (1) 3 Element Beam, (2) Vertical Dual Band VHF & UHF Antennas and Poles, we run the coax, hookup & test all the VHF & UHF radios, connections and electronics. We use the 145.110 repeater on Whiteface Mountain for Medical-Health & Welfare Traffic. We use 147.150 repeater on Rand Hill for Logistics & SAG wagon tracking and traffic. This year for the first time due to Dan Jerry's participation we had APRS tracking on the SAG wagons, which means that he could locate them on a computer screened map of the course on his computer at the Horse Show Grounds. Remember this is all our own equipment, time and expertise that are being volunteered. Due to the mountainous terrain communications- radio waves are often blocked by the 3 - 5 thousand foot high mountains. Many ambulances need 50 watt mobile radios and antennas need to be mounted without making marks or holes etc. Try mounting a magnet mount on a Fiber Glass - Ambulance! Net Controllers like N2ZGN, KC2ALG, WA2LRE, KB2VRO and others work with Essex Co. EMS coordinator Patty Bashaw long hours and constant voice messaging to pass all the traffic and keep things running smooth. Ambulances get to where they need to go and get cycled back to there set locations ASAP because of us ... being there. We work well with the crews and many of the Amateurs develop ties to each Ambulance crew and come back just to work together again. New Amateur's learn the value of working with EMS and passing traffic under all sorts of conditions. Remember "coordination doesn't just happen it is planned" and that's what makes our Amateur Radio Volunteers such a valuable asset to EMS at IRONMAN Lake Placid. Sure, I know that cell phones are available to some of them and so are their radios, but what happens when cell coverage is spotty and those radios have different frequencies, they can't just talk to each other or through Medical Dispatch. from ambulances. That's why we do it w/ Amateur Radio. Remember It was Amateur Radio during 911 that brought communications back up during the chaos, and so too are we ready if the cell phones get over loaded, power failure, who knows what and when communications w/coordination of EMS is needed. That's what we train for ... that's our part in EMS & Ironman USA. Many of those 23 volunteers work around the clock on Sunday doing, helping in many other ways too! Relay vitalsigns to medical personnel etc. We let the Med Tent volunteers know what ETA's are for the Ambulances so that all the Medical Aids and Services are ready there when the Athlete gets out. Amateurs help get support and gear services to athletes all over the course which will get them back into the race ASAP. Finally, on Monday July 26th we get down to the Horse Show Grounds and begin the breaking down of the towers and antennas and pack up to leave it the way it was when we came. The EA3B aircraft, originally designed as a nuclear bomber, was the largest aircraft designed for routine carrier operation. Its large size got it nicknamed "The Whale" as it challenged even the most experienced pilots in landing on a carrier in good weather. The NSA National Vigilance Park was dedicated in 1997 to honor the 180 men that lost their lives in the Cold War collecting intelligence from the air. Indiana Section News for July 2004 Condolances to the family and friends of these amateurs who became a Silent Key during July: Thomas Bowen KA9ERC, Donna, TX (formerly of Kokomo), July 4; George Scheuer WB9SCC, South Bend, July 6. They will be missed. The date for this year's Amateur Radio Awareness Day previously was announced as Saturday September 11. The League has changed it to Saturday September 18. This year there was no particular reason to pick the second rather than the third Saturday, and the second Saturday corresponds with September 11 - a day that will be commemorated for an overeaching reason. While amateur radio played a part in our nation's response to the September 11 attacks, concern has been expressed that by designating September 11 as Amateur Radio Awareness Day, may be perceived as trying to ride the coattails of a national tragedy. At the very least, we may be perceived as insensitive. While the League regrets and apologizes for any confusion that may result, the best course of action at this time is to designate September 18 as Amateur Radio Awareness Day. Please modify any materials or plans accordingly that you have. The FCC has formalized its policy for issuing an emergency communications declaration (ECD) on Amateur Radio Service frequencies. The policy, which became effective August 2, states that ECDs will be issued for VHF or UHF repeaters - if the licensee consents - or on simplex channels in the 60meter band. The FCC will not entertain requests to specifically sequester frequencies in other HF bands for emergency traffic only. Past emergency communications declarations - typically issued during weather-related emergencies - have put frequencies on 75 and 40 meters off limits

to general use in an affected region. The practice has drawn complaints from members of the amateur community - especially from those well outside the affected region - and from emergency nets, which still experienced QRM. The FCC said frequencies in other Amateur Service bands - where emergency nets already have been established - may be used during emergencies under the provisions of para 97.101(c). That rules section stipulates that Amateur Service control operators give priority to stations providing emergency communications "at all times and on all frequencies." Jerry Kutche N9LYA has been working hard in the Central and Southern parts of Indiana to extend the Packet Radio infrastructure. The following stations are now operating on packet: N9POA, Rockville; N9LYA, Mitchell; N9NDS, Cloverdale; WB9FIU, Westport; N9TA, Nashville; and W9OTR, Bedford. For more information on frequencies or how to start your own Packet BBS, please visit: http://www.w9otr.org The July session of the ARES/Emergency net was very short due to extremely poor propagation conditions. For those of you who follow the sunspot activity and its effect on our ionosphere, July has been a very up and down month for propagation on the HF frequencies. The announced CUSEC exercise on July 25 didn't happen due to extremely poor conditions. JUST A REMINDER: The 2-meter FM frequencies that we use are extremely popular and universally used throughout Indiana and all of the U.S. They are THE most publically accessable amateur frequencies that we use. There are literally 100s of thousands of programmable scanners in use by the public, and public service officials. Since almost all amateurs have some type of 2-meter gear and often use it daily, it is easy to forget that anyone, and I do mean ANYONE, besides another amateur could be listening to your local repeater or simplex frequency. That ANYONE, could be an EMA Director, Chief of Police, City/County Councilman, Red Cross Chapter Chairman, the Mayor of your city, Fire Chief, etc.....and the list is unending. I cannot urge you strongly enough to remember that your best amateur radio presence is the one that you need to use on the local repeater. Those citizens who are scanner-wise, will often tune in to the SKYWARN nets during severe weather. The info that trained spotter hams provide is accurate and extremely timely. So, any "cat-calls," derogatory remarks, etc. need to be "verboten" at all times. Even at 3:00AM, you don't know who might be awake, and be listening to their scanner. 'Nuff said! The experts have predicted that the number and severity of storms this year will be at or above normal and, so far at least, it appears that their predictions are right on track. Although everyone hopes that LA will be spared, we also know that it's just a matter of time before a major hurricane hits our state. In addition to hurricanes, our state is a likely target for other serious disasters, both natural and manmade. Therefore, it is very important for every Emergency Coordinator to have an up-to-date written plan that describes what his ARES members should do before, during, and after a disaster. Every ARES member should have a copy of (and be familiar with!) his local group's plan, along with a copy of the LA Section's ARES plan which is available on the section's website at www.laarrl.org/ An excellent training opportunity for everyone interested in emergency communications is our annual SET scheduled for September 25 between 8 and 11 am. Last year we held a joint exercise with our neighbors in MS and STX and we are planning to do so again this year. However, last year our "big picture" scenario was a hurricane; this year we will be "hit" with a major ice storm! ECs and DECs should now be working on their detailed local SET plans with their served agencies. The ARES groups in the southern half of the state may want to include one or more non-weather related local drills during the first hour or so of SET because south LA will not be affected by the ice storm until the second half of the exercise.

Of course, ARES groups in north LA are also free to include non-weather related drills at their local level if they so desire. Formal and tactical test traffic will be handled on HF and VHF voice nets similar to last year's SET. In addition, several ARES groups are planning to handle some traffic this year using one or more digital modes (for example, VHF packet and HF pactor). ARES groups should also investigate Winlink 2000 as another tool that, together with our traditional methods of emergency communications, will increase their ability to serve their local agencies. (Be sure to read the Public Service column in the August and September issues of OST for more information on Winlink 2000.) August 15, 2004 Greetings everyone. Packet radio has been the topic of serious discussion for several months, particularly In light of the interest in the deployment of Winlink 2000 as an email-like user interface. Testing of Winlink 2000 in Michigan has had positive results, and

demonstrations of the system to various officials at both local and state levels has resulted in favorable commentary. Michigan has explored and operated several packet networks and has pioneered in specific areas of packet radio. With the likelihood of Winlink 200 becoming an integral part of emergency communications and a national standard, it is in our interest to seriously examine the status of our various networks and associated stations and develop reasonable plans and guidelines to aid in both the near-term and long range development of an effective and reliable packet radio system in Michigan. Winlink has in fact been successfully implemented and is operational in several regions of Michigan as of this time. I am therefor establishing the Michigan Section Digital Radio Group to spearhead this effort. The key objectives shall include, but necessarily be limited to, the following tasks: examine existing system and networks, determine which are most appropriate to serve the needs of Michigan in terms of reliability, ease of use, redundancy, throughput, ease of implementation, potential for growth, likelihood of obsolesce, availability of equipment and software, interface to existing systems and networks and other requirements to be determined by the group. Recommend, and where appropriate, develop and/or integrate new systems and networks to serve those determined needs and national standards. It must be noted that many pressures and the need for the group to complete their objectives will be high, requiring cooperation from a wide range of nets, clubs, local and state government organizations, and ARES/RACES groups. In some way, most amateur radio organizations in the state will be affected by the actions of this new team, requiring a resolute effort in cooperation and teamwork. Nearly everyone will in some way be a stakeholder in insuring the success of this program. It shall draw its membership from three primary areas: The ARES/RACES program, the NTS Staff, and the amateur radio technical community. Each sector shall be appropriately represented within the following guidelines: The SEC shall chair the body, and permanent seats will be assigned to the STM, the QMN, the ASM for ARPSC and a representative from the ARRL Great Lakes Division. The SM shall serve as an advisor without vote. Each DEC shall select a representative from his District to serve as a member. Members shall serve a two year renewable term, and in the case of the permanent members, concurrent with their other offices. A secretary shall be chosen to record the proceedings and they shall be published and made available to all interested parties. Meetings shall be held as the group determines, but always with formal advanced notice posted on the ARRL Michigan Section web page. The committee shall develop the remaining by-laws. An important requirement is for this newly created team to operate in an open environment where it can freely receive input and suggestions from the entire Michigan amateur community. Likewise, the group charged with reporting its plans and activities to us all on a regular basis. I will make the resources of the Section Staff available for distributing those reports, minutes and commentaries. Of course there are high expectations for this team, and many of us will clearly focus on monitoring its efforts. I am confident that the support of the Michigan amateurs will be behind this effort and we will see near-term very positive results. Thanks to everyone who reported their SARs for July. There was a missing teenage female in the Squaw Mountain area in Mt Hood National Forest. The CARES personnel were in the staging area and ready to deploy when it was reported that the person was located. CARES had 16.5 man hours and 120 miles of driving and no reimbursed. CARES gets many calls like this, because Mt Hood has thousands of people in the area summer and winter. From the ARRL I received this information. "The FCC has ceased issuing 2x3-format Amateur Radio vanity call signs that begin with the prefixes WC, WR, WK and WT (eg, WR1AAA, WC4ZZZ). The Commission has acknowledged that it erroneously granted more than 150 WR and WC-prefix 2x3 vanity call signs from 1997 through September 2003, when it began rejecting such call sign requests. In the late 1970s, the FCC announced a new Amateur Service call sign assignment

system. It provided four standard call sign groups, designated Group A, B, C and D, delineated by license class and issued sequentially with no backfilling. The FCC's Bill Cross, W3TN, recently told the nation's volunteer examiner coordinators (VECs) that the FCC also had a "Group X." These included WC (RACES), WR (repeater), WK and WT-prefix 2x3-format call signs reportedly reserved for special-use licenses. The FCC stopped issuing repeater call signs in 1983 and ceased renewing RACES licenses in 2000. I hope to see everyone there! I received a report from Marc Tarplee N4UFP, TC regarding technical issues that he and his team of TS's are working on at the current time. I was interested to see that Echolink was being added to another one of the repeaters on the SC coast. I was also interested that a "phase-in" period was planned to allay fears regarding the implementation of Echolink on that repeater. For those who have not heard of Echolink, it is a way of connecting hams and distant repeaters via the internet via VoIP (Voice over the Internet Protocol). For example, you could access a local Echolink Node and connect to an Echolink Node on a distant repeater or simplex frequency. You could even access the distant repeater directly via your own computer. As you might guess, you must be authorized as a licensed ham to use the Echolink system, and that authorization is performed prior to being able to access the system from a computer. For those interested in further information, the ARRL has just published a book "VoIP-Internet Linking for Radio Amateurs". I have heard a lot of interesting comments regarding the Echolink system. I heard one comment from someone on the ARRL-SC team stating that "If I wanted to talk over the internet, I would join a chat room". Another comment was "The Internet is NOT ham radio". Still another, "Echolink will bring about the demise of Amateur Radio". I certainly respect the traditions of yesteryear, and encourage that they continue. For example, I was very gratified to see that the ARRL has set up an AM operating station at W1AW. Although AM has been overshadowed by Single Sideband over the years, it is great to see that hams of the future will see where our roots came from. By the same token, I feel the need to be progressive, and investigate new technologies. We discuss whether or not we can communicate with a certain area at a certain time of day. Propagation may or may not cooperate, and we may be unable to communicate. How about having at least 95% certainty that we will be able to communicate with a given area on the globe reliably? It is an interesting concept. How about listening to a Skywarn net in progress in an affected area from your home hundreds of miles away (but still in the path of the storm)? What about getting message traffic out of a disaster area with directional antennas and an Echolink node just out of the disaster zone? This technology has been very controversial, to be sure. I look on Echolink as another resource that we have at our fingertips. To this end, I set up a local Echolink node at my QTH. I realized the only way I could really learn all the ins and outs of Echolink is if I actually participated! I have had a number of great QSO's all around the world, and have kept in touch with friends around

the USA. Our County Emergency Preparedness Director who has recently become a ham is VERY interested in the technology. Any technology that is new may be difficult to accept at first. I view the internet and VoIP as complementing our current technologies rather than replacing them. My best wishes to the group adding Echolink to their repeater, and I hope they keep us informed as to their progress. That's it for this month! I hope to see everyone at the Shelby Hamfest!
